1. OBJECTIVE OF THE MOU


2. PROPOSED MODE OF COLLABORATION

CMBR and Department of Microbiology, Rajarshi Shahu Mahavidyalaya propose to collaborate through: -

- a) **Internship, Dissertation work , Offline and Online Training** of under-graduate students, post- graduate students , research scholars and Faculties of Department of Microbiology, Rajarshi Shahu Mahavidyalaya.
- b) Providing access to utilizing the lab facilities of CMBR.
- c) Any other appropriate mode of interaction agreed upon between CMBR and Department of Microbiology, Rajarshi Shahu Mahavidyalaya CMBR, being a service provider to .
- d) Department of Microbiology, Rajarshi Shahu Mahavidyalaya will charge a certain amount as fees for the above services which is mutually agreed upon by both Parties.

3. EFFECTIVE DATES AND AMENDMENTS

- a) This MOU shall take effect upon signing by both Parties and shall remain in effect for a period of Three (3) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.
- b) The MOU may be renewed at the end of this period by mutual written agreement by both Parties.
- c) The provisions of this MOU may only be amended or waived by mutual agreement by both Parties.
- d) Any Party may terminate this MOU and any related agreement for any reason by giving thirty (30) days prior written notice to the other Party.
