UNDERSTANDINGS

Given the background, both the parties understand and agree that:

- 1. INTENTIONS: Green Vitals Biotech, and Rajarshi Shahu Mahavidyalaya, Latur (Autonomous),
 Department of Microbiology desire to enter into a long-term mutually beneficial partnership. The two
 parties desire to leverage on mutual strengths: Green Vitals Biotech has understanding and experience
 in manufacture of biofertilizers, organic agricultural inputs and soil testing. Rajarshi Shahu
 Mahavidyalaya, Latur (Autonomous), Department of Microbiology has education/training programs

The information shared for the purpose of this agreement shall not be disclosed to outside parties nor used to its sole benefit without consent of the other party.
