**MEMORENDUM OF UNDERSTANDING (MOU)**

4. It is further agreed that, the Maitree Institute shall also train the staff members for Soft Skill development by organizing special training programme as per the needs and requirements.
5. The Maitree Foundation, Latur shall develop the study material as per the course curriculum and be provided to the students.

7. Any dispute between the parties shall be settled by mutual negotiation or through arbitration.
