1. Preamble

Pratibha College of Commerce & Computer Studies, Chinchwad, Pune is well known college in PCMC area for arranging Job Fair, Corporate Week, Soft Skill Development courses etc. which open number of opportunities to the students for creating job awareness and placement.

Rajarshi Shahu Mahavidyalaya (Autonomous), Latur was established with a Mission of "Pursuit of Excellence" in higher education. Within a short span of period, the college has received social and academic recognition which is now called as "Shahu Pattern" in Maharashtra. Taking into consideration the mile stone laid down by the institution in the field of education, the Govt. of Maharashtra honored this institution with an "Ideal Education Institution" in the year 2000. We are also the recipient of "Best College Award 2021(Urban)" by our parent University (Swami Ramanand Teerth Marathwada University, Nanded). The college has accredited by NAAC as 'B++' grade with a CGPA of 2.99. The UGC has recognized this college as College with Potential for Excellence (CPE) Status for consecutively third time. The college is first and only non-professional Autonomous Institution in Marathwada region. The college is also recipient of DST-FIST support.

There is a need to exchange new technologies and information in higher education. Therefore, it helps in improving the teaching methods and quality of students in higher education. In order to brighten the future of the students and for sustainable development, it is necessary to have a Memorandum of Understanding (MoU) for implementation of various academic activities in various universities, colleges and other educational institutions providing higher education. With this in mind, we are signing a Memorandum of Understanding between Pratibha College of Commerce & Computer Studies, Chinchwad, Pune and Rajarshi Shahu Mahavidyalaya (Autonomous), Latur for the exchange of educational activities.

2. Objectives

This Memorandum of Understanding (MoU) is entered into on this day of 28th February 2022 by and between Pratibha College of Commerce & Computer Studies, Chinchwad, Pune and Rajarshi Shahu Mahavidyalaya (Autonomous), Latur agree that cooperation in student and faculty exchanges would be mutually beneficial. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity that would further the goals of each institution. Such interaction may include cooperation in a variety of joint academic and educational activities. Pratibha College of Commerce

& Computer Studies, Chinchwad, Pune and Rajarshi Shahu Mahavidyalaya (Autonomous), Latur have mutually agreed to collaborate with each other in the following areas.

- Exchange of Faculty for purposes of education and/or research.
- Exchange of students for limited period of time for purposes of education and/or research.
- Organization of Joint conferences and workshops.
- Organization of Joint field work, Study tour, etc.
- Any other areas of mutual interest.

The parties anticipate that a number of these initiatives will occur during the period of this MoU.

However, neither party is obligated to agree to any minimum number of activities, nor is this MoU intended to preclude either party from entering into similar agreements with other institutions. The available facilities of colleges will be utilized with mutual consent and subject to the feasibility. Both parties agreed to enter into a collaborative understanding on the terms and conditions enumerated in this MoU.

3. Student and Faculty Exchange:

The parties will agree to share Online Courses designed and developed by either institute for the interest of students and to enhance the knowledge of students and faculty as well. Both the parties will also agree to develop any Online Course Material/ Video lectures on different technologies/ academic topics in the interest of students mutually and may exchange the resources. Also both parties agree to organise and share research oriented activities.

4. Disclaimer:

This MoU is not intended by Pratibha College of Commerce & Computer Studies, Chinchwad, Pune and Rajarshi Shahu Mahavidyalaya (Autonomous), Latur to constitute, create, give effect to, or otherwise recognize a joint venture, agency, partnership, or formal business organization of any kind. Each party hereto shall act as an independent entity and neither shall act as an agent of either organization for other purposes. Neither party has the authority to bind the other party.

5. Validity:

This MoU would remain valid for a period of three years from the date it is signed by the parties and is renewable on mutual consent for such further period as agreed upon.

6. Term and Review:

The MoU shall be reviewed three years from the date of signing of this MoU. Either party can terminate the MoU after giving one month's notice to the other party subject to fulfillment of commitments already agreed upon.

7. Amendments:

This MoU constitutes the entire understanding between the parties hereto. Except as otherwise provided herein, no addition, amendment to or modification of this MoU shall

be effected unless it is in writing and signed by and on behalf of both parties by their respective authorized signatories.


8. Any Dispute:

Any dispute arising out of this MoU will be settled by mutual negotiations between the two parties. For agreed upon activities, both institutions will make available their facilities, staff and students. This MoU will take effect on and will be valid for three (03) years from the date noted in the first line of this document unless terminated by one of the parties. Either party may withdraw from this MoU provided written notification of the withdrawal is given to the other party atleast One (1) month prior to the desired withdrawal date. This MoU may be renewed for another period of three (3) years upon mutual written consent of the parties before the expiration date. Each institution will have copies of this agreement.
