WHEREAS:

UNDERSTANDINGS

Given the background, both the parties understand and agree that:

1. INTENTIONS: Rajarshi Shahu Mahavidyalaya (Autonomous), Latur , Department of Microbiology and Reliable's Shree Industrial Training Centre, desire to enter into a long-term mutually beneficial partnership. The two parties desire to leverage on mutual strengths: **Reliable's Shree Industrial Training Centre**, has understanding and experience in offering Hands on training of handling advanced analytical instruments such as HPLC, GC, UV-VIS Spectrophotometer, Friabilator and FTIR and has facility to conduct research in the areas of analysis of drugs, microbial products and chemical compounds. Rajarshi Shahu Mahavidyalaya (Autonomous), Latur, Department of Microbiology has education/training programs that can be of interest for the students of this area. The mutual intention is to construct a Win-Win relationship between the two parties so that each could leverage its expertise into their services or programs.

In that case, the party providing the services shall invoice the other party after written pre-approval of the other party regarding the terms of retaining these additional services.

5. PRESS RELEASES: Either party is free to announce this relationship or intention of working together on the web site or local/national/international media. Expenses for such activities will be borne completely by the party conducting the release.

6. NON-DISCLOSURE AGREEMENT: As a corollary to the stated intent, in the course of working together both parties may share confidential information about their working, clients, partners,

etc. with the other party. The information shared for the purpose of this agreement shall not be disclosed to outside parties nor used to its sole benefit without consent of the other party.

7. **SOLICITATION:** Each party to this MoU agrees not to approach to other's customers, partners or contacts directly or indirectly.

8. **DURATION and VALIDITY:** This agreement is for a period of five years and is automatically renewed every 5 years until it is superseded by another Agreement or is terminated with a one year notice by either party.
