PURPOSE:

The purpose of this agreement is to promote co-operation in Education and Research facilities in Shri Sant Janabai Education Society's, Arts, Commerce and Science College, Gangakhed and Shiv Chatrapati Education Society's, Rajarshi Shahu Mahavidyalaya (Autonomous), Latur

TYPES OF CO-OPERATION:

Through this memorandum, both parties affirm the values of international collaboration and agree to promote the below mentioned activities.

- ✓ To share academic facilities,
- ✓ To share Research facilities to promote the research of mutual interest,
- ✓ To provide opportunities for faculty to share laboratory and library facilities,
- ✓ Jointly organization of National/ International activities,
- ✓ Faculty and student exchange in various activities.

AS MUTUALLY AGREED:

- This agreement places no obligations or supplementary funding commitments on either Party.
- The activities will be defined through Separate program agreement which include details of commitment of resources (financial or other) required by each institution.
- Subsequent program agreement must be approved by in writing by authorised representative of each institution as Principal, Shri Sant Janabai Education Society's, Arts, Commerce and Science College, Gangakhed and Shiv Chatrapati Education Society's, Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will decide mutually about development of future activities.

TERMS:

- ✓ This agreement will become effective after the date signed by both parties. It shall remain valid for a period of Five (05) years from the date of signature, with understanding that it may modified by written mutual consent of both Parties. This agreement may be terminated by any Party with advance any notice of at least thirty (30) days. Upon notice of termination both institutes Shri Sant Janabai Education Society's, Arts, Commerce and Science College, Gangakhed and Shiv Chatrapati Education Society's, Rajarshi Shahu Mahavidyalaya (Autonomous), Latur agree to work in good faith to enable visiting scholars to complete their respective research program and any other academic related activities unhindered by the termination. This agreement may be extended by mutual Consent of two parties after the period of Five (05) years, and it must renewed in written.
- ✓ This memorandum of understanding Completed is hereby signed in two (2) copies with one (01) copy remaining in the possession of each institution.
