BY AND BETWEEN

Shiv Chhatrapati Shikshan Sanstha Latur running Rajarshi Shahu Mahavidyalaya (Autonomous), Latur represented by its Principal Dr. Mahadev Gavhane which expression shall, where the context so admits, be deemed to include its successors, executors and administrators of the ONE PART

AND

SynchroServe Global Solutions Pvt. Ltd., Hyderabad (herein after referred to as the "SynchroServe Global Solutions Pvt. Ltd., Hyderabad") a Company registered under the Company Act,1956, through its Mr. Pradheep Kumar Nama – Director Finance having it's registered/approved office at 207 2nd floor Maximus Towers 2B K. Raheja MindSpace, Hitec City Madhapur, Hyderabad 500081 Ph no 040-40320320 (which expression,unless it be repugnant to the context or meaning thereof, shall be deemed to mean and include their executors, administrators and assigns), party of the SECOND PART.


WHERE AS, the University Grants Commission has initiated a scheme to provide competency based skills under the National Vocational Educational Framework (herein after to be referred as NSQF);


WHERE AS in terms of the said scheme launched by University Grants Commission, has extended invitation to various Institutions/ Organizations to join as Vocational Educational Institutions to provide education component and Skill Knowledge Providers to provide Competency Based Skills.

WHERE AS under the scheme a Skill Knowledge Provider is required to perform the role and function of providing hands on skill training in a specific sector i.e. in the IT Sector, the Skill Knowledge Provider shall be the training sector of authorized IT Company located preferably all over the Country. The Skill Knowledge Provider could also be one who is established for imparting hands on skills or training in an IT an ITeS sector;

WHERE AS the First Party is to participate as an Institution to register students for B. Voc. (Computer Technology) under the National Skill Qualification Framework (NSQF) of UGC;

WHERE AS the Second Party has expressed its keen interest and desire to be a key Partner in the execution of the National Vocational Educational Qualification Framework in terms of the objectives of the scheme and policy as highlighted and specified in the said framework and particularly in view of the desire and interest of **SynchroServe Global**





Solutions Pvt. Ltd., Hyderabad to join and Partner with **Rajarshi Shahu Mahavidyalaya** (**Autonomous**), **Latur** in providing competency based skills through its centers which shall act as Skill Knowledge Provider for the purposes of the scheme;

WHERE AS Both parties have held discussions and agreed for collaboration for conducting Vocational Education Programme(s) under the education scheme of the NSQF, whereby Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will impart and award credits for the "Academic content" of the Curriculum and SynchroServe Global Solutions Pvt. Ltd., Hyderabad will provide skill training through its training centers called SynchroServe Global Solutions Pvt. Ltd., Hyderabad- SKP's and will impart and award credits for such 'Skill oriented training' content of the Curriculum to the registered students.

WHERE AS the Second Party has registered itself with the University Grants Commission (UGC)/ Concerned Authority and obtained approval thereof to participate as **SynchroServe Global Solutions Pvt. Ltd., Hyderabad** under the National Skill Qualification Framework (NSQF);

THERE FORE, both the parties hereby agree to conduct Vocational Educational Programme initiated by UGC under National Vocational Educational Qualification Framework, on the following terms and conditions:

- The SynchroServe Global Solutions Pvt. Ltd., Hyderabad agrees that centers approved and recognized by SynchroServe Global Solutions Pvt. Ltd., Hyderabad (herein after to be referred as SynchroServe Global Solutions Pvt. Ltd., Hyderabad -SKP"), shall act and perform the role of Skill Knowledge Provider to provide hands on skill training in specific sector such as IT-ITES, SSC, NASSCOM.
- 2. The SynchroServe Global Solutions Pvt. Ltd., Hyderabad agrees and undertakes that its SynchroServe Global Solutions Pvt. Ltd., Hyderabad shall register with NASSCOM for conduct of training modules under the Vocational Educational Programme and shall perform following functions:
 - a. Announce the schedule of modules for calendar year.
 - b. Register students for the modules.
 - c. Conduct the modular training.
 - d. Conduct examination/evaluate the student, award the grade indicating level of skills acquired.
 - e. The **SynchroServe Global Solutions Pvt. Ltd., Hyderabad** SKP shall register students for evaluation the Skill Modules, who have acquired skills on their own.
- 3. The Second Party agrees that the following responsibilities shall be undertaken by the Rajarshi Shahu Mahavidyalaya (Autonomous), Latur Academic Training centers:
 - a. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur- shall plan the Vocational Education Programme(s) to be offered in the Academic Year concerned and inform the SynchroServe Global Solutions Pvt. Ltd., Hyderabad- SKP's about the same at least two months prior to the date of commencement of the Programme (s).





b. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur shall announce and inform through its prospectus and information on its Website, the Vocational Education Programme(s) it plans to offer in the academic year concerned for the information of the prospective students and invite applications for admission from interested candidates at least two months prior to the date of commencement of the Programme(s).

c. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur shall follow the admission norms of UGC and the State Govt. concerned. The admission shall be made strictly on merit basis. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will then upload the names and details of the selected

students on the UGC Web-Portal.


d. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will have the right to collect fees from the students, as prescribed by the UGC for each sector, towards:

- 1. Registration, 2. Course/ Skill component and 3. Evaluation of the Academic/ Skill portion of each Level of the Programme. A portion of the fees as agreed upon by the Rajarshi Shahu Mahavidyalaya (Autonomous), Latur Academic Centre and the SynchroServe Global Solutions Pvt. Ltd., Hyderabad - SKP's shall be turned over to the SynchroServe Global Solutions Pvt. Ltd., Hyderabad- SKP's.
- e. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will send to the SynchroServe Global Solutions Pvt. Ltd., Hyderabad - SKP the Level wise and Sector-wise lists of students registered for Vocational Education Program(s) in the Sectors.
- f. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will conduct appropriate Classes for the Academic content of the Curriculum of the Vocational Education Programme(s) so as to complete the Academic portion within prescribed time.
- g. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will conduct final examinations and evaluate the students for the Academic portion of the Programme(s) as per the rules and regulations of the Technical Board or University as the case may be.
- h. After receiving a 'Statement of Credits for the Vocational/ Skill portion of the students from the SynchroServe Global Solutions Pvt. Ltd., Hyderabad -SKP, the Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will send the combined Academic and Vocational/ Skill portion credits of the students to the Examination Section of Rajarshi Shahu Mahavidyalaya (Autonomous), Latur as the case may be.

i. Wherever such provisions are made by the UGC, as the case may be, the Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will award a 'Level Certificate' to the student who has successfully completed both the Academic and the Vocational/Skill portions of the particular Level.

The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur shall maintain a record of the registered students and Certificates issued and upload the same

on the UGC Web-Portal.



4. General:

Fees to be charged to students:

a. The Level-wise fees to be charged by the Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will be informed to the student by the Rajarshi Shahu Mahavidyalaya (Autonomous), Latur as well as the SynchroServe Global Solutions Pvt. Ltd., Hyderabad- SKP before his/her registration for the Programme;

b. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will collect from the student and retain with itself the 'Academic Portion Fees' and the SynchroServe Global Solutions Pvt. Ltd., Hyderabad- SKP will be given the 'Vocational / Skill Portion Fees' by the SynchroServe Global Solutions Pvt.

Ltd., Hyderabad;


c. The Rajarshi Shahu Mahavidyalaya (Autonomous), Latur will collect the total fees for the Programme from the students and will transfer the 'Vocational/Skill Portion Fees' against the number of students to be sent for training with mutual consent of both parties. After receiving the fees SynchroServe Global Solutions Pvt. Ltd., Hyderabad- SKP will issue Registration cards to the students at least 7 days before the onset of training.

5. No Confidentiality:

There shall not be any confidentiality of any information disclosed to by both parties to each other, either in operationalizing this agreement or for the purposes of implementing this agreement. The information sought under Right to Information Act or otherwise by any student, shall be promptly made available.

6. Effective Date:

This agreement is effective from the date signed by both the parties will be valid for a period of three years until determined, suspended or terminated earlier.
