MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

RAJARSHI SHAHU MAHAVIDYALAYA, LATUR

AND

V S INFOTECH, LATUR

Rajarshi Shahu Mahavidyalaya, Latur (Autonomous) a premier educational institute and **V.S. Infotech, Latur** wishing to promote cooperation in the field of knowledge sharing and giving special emphasis on expansion of skill based programs in higher education, to serve multiple needs, including :-

- i. Career oriented education and skill development.
- ii. Contracted training and education programs for local employers.
- iii. High-touch remedial education for secondary school graduates not ready to enroll in traditional colleges, giving a path to transfer to three or four year institutions and
- iv. General interest courses to the community for personal development.

Keeping in view such important measures **Rajarshi Shahu Mahavidyalaya, Latur** and **V.S. Infotech, Latur** enter into this Memorandum of Understanding (MoU). Both the institutes agree on following activities :

1. **Rajarshi Shahu Mahavidyalaya, Latur** in consultation with **V.S. Infotech, Latur** will develop a curriculum relevant to the Industry under the overall guidance of the Board of Studies, Academic Council and Governing Body.
2. **V.S. Infotech, Latur** shall support the student and teacher communities through Technical Support, Workshops, Faculty Development Programmes (FDPs) and students internships, trainings and placement.

3. The subject of present Memorandum of Understanding is the establishment of a scientific and educational cooperation between **V.S. Infotech, Latur and Rajarshi Shahu Mahavidyalaya, Latur, M.S. India.**
4. Both sides shall endeavor to, as for as their financial means allow them.
 - Exchange of faculty members and research associates.
 - Technical Support.
 - Exchange of graduate students.
 - Exchange of research materials and scientific information.
 - Holding joint workshop and symposia
 - Providing training to the students and assist them for the placement.
 - Other forms of cooperation made by mutual agreements.

Guidelines for these activities will follow the policies and procedure which govern such arrangement at each institution.


5. The financial supports for the activities mentioned in Article 2 will be sought from the national and / or private organizations of both sides.
6. This memorandum of understanding shall become effective from the date of its signing by the representatives of both institutions and shall remain in effect for five (5) years and can be extended by the written mutual consent. Either side may terminate this agreement at any time by giving a written notice in six (6) months advance to the other institution.
