MEMORANDUM OF UNDERSTANDING (MoU)

ARTICLE I - PURPOSE AND SCOPE

To support this goal, Both Parties will work together to extend services that meets needs of our communities, if required at the site of the beneficiary.

Both Parties should ensure that the collaborative activities are conducted in compliance with all applicable laws, rules and regulations by the apex bodies of education and Indian Government.

The undersigned parties will put forth a good faith effort in providing resources, both tangible and intangible, in assisting the other parties in this collaborative relationship to achieve their respective goals.



ARTICLE II -BACKGROUND OF THE PARTIES

FIELDS OF COLLABORATION

Rajarshi Shahu Mahavidyalaya shall undertake the following responsibilities:

- 2) To verify hours completed by each RSML participant.
- 3) To provide all the infrastructure facilities to the students.
- 4) To prepare detailed curriculum of the course in consultation with all the industry partners, Board of Studies and industry associations.
- 5) To appoint the faculty and related staff.
- 6) To function all other activities as per UGC rules and guidelines for the course.
- 7) To give the credits and to evaluate the participants.
- 8) To award the certificate/diploma/Advanced diploma/degree certificate to the participants.

Industry Partner shall undertake the following activities.

- 1) Provide any necessary training required.
- Provide technical knowledge for the processing of food, especially bakery, confectionary, sweets, spicy food items, cake and cookies, required to complete each part of the course and related project.
- 3) Be in attendance for any events coordinated through this partnership.
- 4) Provide guidance and supervision to participants.
- 5) To assist for an evaluation of each RSML participant.
- 6) To help the participants for the placement.

ARTICLE IV - TERMINATION OF RELATIONSHIP

Both parties fully recognize their mutual legal capacity to draw up the present agreement. The collaborative relationship under this MoU, is at-will. Upon the unilateral discretion of each party or any combination of them, the collaborative relationship under this MoU, may be terminated at will without an advance notice.



ARTICLE V - TIME FRAME

The terms of this MOU shall terminate after five years from the date of sign

ARTICLE VI - AMENDMENTS TO MOU.

Any and all of the provisions included in this MoU, may not be altered unless each of the undersigned parties has agreed to the amendment(s), and the parties' agreement is reflected in a written modification to this MoU, that is duly executed by each of the undersigned parties.

ARTICLE VII - FUNDING

This MoU does not include the exchange of funds between the two parties. As per UGC Rules the renumeration/honorarium will be paid to the faculty/staff of the Dept. of Biotechnology and Food Processing Technology, Rajarshi ShahuMahavidyalaya (Autonomous), Latur based on the nature of Industry Partner's Role and training programme activities/ consultancies conferred as per the norms. Still, if the Industry Partner wish to extend Capital to college for the collaborative activity by Rajarshi Shahu Mahavidyalaya (Autonomous), Latur such as Educational Forum, Rajarshi ShahuMahavidyalaya (Autonomous), Latur welcome the same.

ARTICLEE VIII - RECORD RETENTION

All records must be retained with Rajarshi Shahu Mahavidyalaya (Autonomous), Latur and Industry Partner from the date of MoU.

ARTICLE IX - MERGER CLAUSE

This Memorandum of Understanding represents the parties' final and complete understanding and agreement. There have been no other guarantees, agreements or warranties made. Only a written agreement, as specified in ARTICLE VI of this MoU, may be used to change this MoU.
