This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution. Principal, *Dr. M. H. Garhane* *B*, will serve as the primary liaison between the two institutions to facilitate the development of future activities.

Terms:


This Agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. Upon notice of termination both Shri Kumarswami Mahavidyalaya, Ausa, and RAJARSHI SHAHU MAHAVIDYALAYA (Autonomous), LATUR, agree to work in good faith to enable visiting scholars to complete their respective research programs unhindered by the termination. The agreement may be

extended by mutual consent of the two Parties after the five-year period, and it must be renewed in writing.


This Memorandum of Understanding completed is hereby signed in two (2) copies with one (1) copy remaining in the possession of each institution.
