### MEMORANDUM OF UNDERSTANDING (MoU)

# III. RAJARSHI SHAIIU MAHAVIDYALAYA'S RESPONSIBILITIES UNDER THIS MoU:

Rajarshi Shahu Mahavidyalaya (Autonomous), Chandranagar, Latur shall undertake the following responsibilities:

- · To enroll the students.
- · To provide all the infrastructure facilities to the students.
- To prepare detailed curriculum of the course in consultation with the industry partners,
   Board of Studies and industry associations.
- To appoint the faculty and related staff.
- To conduct all other activities as per UGC rules and guidelines for the course.
- · To verify hours completed by each student enrolled.
- To conduct examinations and evaluate the performance of the students.
- To award the Certificate / Diploma / Degree certificate to the eligible students
