7.3 Give two Best Practices of the institution (*please see the format in the NAAC Self-study Manuals*)

**1. Earn while learn scheme for the needy students with poor economical background.**

**Context:**

Latur being a semi-urban place, wherein majority of college education aspirants are from rural farmer back ground and low income group urban community. These students do not have adequate financial support to meet their educational needs. Considering this aspect college decided to run Earn While learn scheme since 1998 where in students are allowed to earn their minimum wages by campus cleaning during their off study hours while they learn.

**Objectives:**

1. To help the needy to complete their higher education .
2. To respect the dignity of work and make them self-sufficient.

**The Practice:**

The actual practice is as follows:

- 1) Applications are invited from the student in the beginning of year .
- 2) Screening of applications based on set criterion to select the genuine students is done
- 3) Students are allowed to earn their minimum wages by campus cleaning during their off study hours while they learn. These students are also assigned Exam Supervision work.
- 4) The minimum wages are Rs. 30 per hour.
- 5) Best Students who performed well in the earn and learn scheme are rewarded with special prize during annual social gathering in presence of all students. It is planned to provide midday meal to the students participating this scheme.

**Obstacles faced:**

- 1) In its initial phase of the scheme students were hesitated to join the earn and learn scheme.
- 2) Even their parents were reluctant for participation of their wards in the scheme.

**Evidence of success:**

- 1) Large number of students (225-250) apply for registration in the scheme of which only around 70 are selected.
- 2) The perceptible outcome of this practice resulted in cleanliness of the campus.

**Resources required:**

1. Two coordinators are required to monitor and run the scheme
2. On and around a sum of rupees 6 lakhs per annum is required to run the scheme.



## **2. Value/ moral Education to students by involvement in onsite philanthropic projects.**

### **Context:**

Presently there are several issues prevailing in the society e.g. 1) Children of HIV affected families, 2) Old age problems related with poor visibility 3) Issues related to Neglected parents ('Vradhashram'). In order to address these and such other issues the college under autonomy has introduced moral education as a compulsory course for UG first year students since 2013-14.

### **Objectives:**

1. Help to eradicate the prevailing social issues in the society such as 1) Children of HIV affected families, 2) Old age problems related with poor visibility 3) Issues related to Neglected parents ('Vradhashram').

**The Practice:** The actual practice is as follows:

- 1) Value/ moral education is introduced as a compulsory course of 50 marks for UG First year students .
- 2) Under this course renowned social workers/Activist are invited for delivery course content and share their experiences with the students related to above issues during their theory interactive sessions.
- 3) As a part of practical experience students are asked to visit local NGOs involved in addressing these issues and the students interact with Children of HIV affected families, Old age persons with poor visibility and Neglected parents living in 'Vradhashram'.
- 4) Students by involvement in such onsite philanthropic projects are asked to write a report about their experiences

### **Obstacles faced:**

- 1) Mismatch between college time table and NGOs Working hours.
- 2) NGOs do not spare adequate time for interaction with the students during visit hours. .

### **Evidence of success:**

- 1) Tremendous and overwhelming response from the students for the field visits to NGOs is received.
- 2) Students during the field visit hours have extended their helping hands to the needy persons suffering from these issues.
- 3) Students after completing the projects have expressed that they will take care of their old age parents, help HIV affected children and persons with poor visibility.

### **Resources required:**

1. Tie ups with NGOs for field visits.
3. Conveyance arrangements of students for Visiting NGO sites.
4. Faculty wise coordinators for execution of course.
