Date 25/2/2013



A National Conference on "Recent Trends in Mathematics and their Applications in Computer Science" RTMACS2014 was hosted by Department of Mathematics and Computer Science, Rajarshi Shahu College Latur on 17th and 18th January 2014.

Hon. Dr. V. M. Pandharipande, Vice-Chancellor, Dr. B.A.M. University, Aurangabad was the chief guest for the inaugural function of the conference and Dr. Gopalrao Patil, Ex-MP and President, Shiv Chhatrapati Shikshan Sanstha, Latur chaired this function.

In order to have good interaction between participants and resource persons, scientists, two day conference was divided into 10 sessions.

DAY-1 (17 January 2014)-

Technical Session-I

Dr. P. S. Hiremath, Gulbarga University, Gulbarga delivered his invited talk on "Green Computing". His lecture motivated researchers to interact with him. "Intellectual Property Protection and Patent Filing"

Intellectual Property Rights (IPR) are at the frontier of today's knowledge economy and avail researchers to protect their discern research inventions. Taking the same leaf our renowned institute has arranged a One Day State Level Workshop on **"Intellectual Property Protection and Patent Filing"** on 21st April '2017, Friday financially supported by Shiv Chhatrapati Shikshan Sanstha, Latur.

This workshop was arranged to inculcate the basic knowledge and importance of IPs and patents in faculties of our college and to give deeper insight to our faculties to explore requisites for patent, prosecution and other relevant needful.

An eminent scientist Dr. M.K. Dongare from National Chemical Laboratory, Pune was availed us as Chief Guest and Resource Person for this workshop. The registration for the organized workshop was done between 9:30 to 10:30 am. The inauguration of the workshop was done by Dr. Gopalrao Patil (Chairman, Shiv Chhatrapati Shikshan Prasarak Sanstha, Latur) followed by lamp lightening. Furthermore, key note address was given by the resource person and subsequently the Principal and Chairperson of the workshop delivered the noteworthy information regarding the objectives and purpose of the workshop. Consequently, the talk on IPR was delivered by the Dr. M.K. Dogare.

He outlined preface to Intellectual Property (IP) and its rights, need for protection of IP, requisites for filing patent, patent filing procedures, types of Patents, its prosecution, time bounds and expenses. Also he put his views regarding various forms of IPs, who own the rights of the IPs. He illustrated rights for tangible property and IPR. He made the delegates acquainted with the patent acts and has given few representative examples of the crimes occurred and the legal actions taken against the culprit institutes. The learned cleared that products as well as patents can be registered for patents. He explained the concept underlying IP management and highlighted innovator institutes in India. In IP management he explained that it can increase revenue through litigation, through licensing and renting the IP, further more he cleared that the IP enhances the reputation/prestige of individual and hence of the institute. Furthermore, he illustrated various tools used in IPR. He outlined various types of IPR such as Trademark, Copyrights, Industrial Designs, Patents, etc. He made the faculties familiar with the concept of

patents, locations to file patents and by the rights conferred by the patents. He explained three integral patentability factors namely novelty, non-obviousness (inventive step/steps and industrial applications with example. In his gracing talk he explored the ways to file patent applications in foreign countries, conventions and PCT filling procedures, etc.

Afterwards, the lunch was arranged by the college followed by second session of the invited talk. For this distinguished workshop 100 delegates (Assi. Prof., Asso. Prof. & Professor) from our institute get participated. After the talk program chairperson remark was given by Hon'ble Chairman of our parent institute Shiv Chhatrapati Shikshan Prasarak Sanstha, Latur. Moreover, in the valedictory function the Organizing Secretary of the workshop and Chairman of Research Committee Dr. S.J. Phule, summarized the remarkable facts and achievements of the workshop and proposed the vote of thanks and with the consent of the Chairman of the program the one day workshop was ended 5:45 pm.


This workshop was arranged to indoctrinate the faculties and to induce the basic knowledge and importance of IPs and patents in faculties of our college and to give deeper perspectives to our faculties to see the sights for patent, prosecution and other pertinent needful.

A distinguished learned Dr. M.M. Dr. M.M. Betkar, Principal, Kumar Swami Mahavidyalaya, Ausa, Dist-Latur was with us as Chief Guest and Resource Person for the workshop. The registration for the organized workshop was done between 9:30 to 10:30 am. The inauguration of the workshop was through honorable Chairman Dr. Gopalrao Patil of our renowned parent institute Shiv Chhatrapati Shikshan Prasarak Sanstha, Latur followed by lamp lightening. Besides, key note address was given by the resource person and consequently the Principal and Chairperson of the workshop conveyed the remarkable information regarding the objectives and principle of the workshop. Subsequently, the talk on IPR was delivered by Dr. M.M. Betkar.

He explored preface to Intellectual Property (IP) and its rights, need for protection of IP, basics for filing patent, patent filing actions, categories of Patents, its prosecution, time limits for various steps and expenses for patents. Also he outlined his perceptions regarding various forms of IPs, how the institute or individual can own the rights of the IPs. He elaborated his discussion on rights for substantial property and IPR. He made the delegates familiar with the patent acts

and has given few representative examples of the crimes occurred and the legal actions taken against the culprit institutes with. The learned cleared that products as well as patents can be registered for patents. He highlighted the ideas underlying IP management and depicted leading innovator institutes in India. In IP management he explained that it can flourish revenue through litigation, through licensing and renting the IP, further he cleared that the IP enhances the reputation/prestige of individual and hence of the institute. Furthermore, he exemplified various tools used in IPR. He gave focus on various types of IPR such as Trademark, Copyrights, Industrial Designs, Patents, etc. He made the faculties acquainted with the concept of patents, places to file patents and by the rights conferred by the patents. He explained three integral patentability factors namely novelty, inventive step/steps and industrial relevance with example. In his elegance talk he put the ways to file patent applications in foreign countries and India, conventions and PCT filling procedures, etc.

Consequently, the lunch was arranged by the college followed by second sitting of the invited talk. For this notable workshop 95 delegates (Assi. Prof., Asso. Prof. & Professor) from our institute get participated. After the talk, the program chairperson remark was given by Hon'ble Chairman of our parent institute. Additionally, in the valedictory function the Organizing Secretary of the workshop and Chairman of Research Committee Dr. S.J. Phule, outlined the remarkable facts and attainments of the workshop and proposed the vote of thanks and with the consent of the Chairman of the program the one day workshop was winded 5:45 pm.


Valedictory function:
