Mechanism of Evaluation of PO-CO Attainment

Rajarshi Shahu Mahavidyalaya has implemented a well-defined Outcome-Based Education (OBE) policy, aiming to enhance the teaching-learning process and achieve optimal learning outcomes. The learning objectives and course outcomes (COs) are clearly stated and integrated into the curriculum, aligning with the institution's vision and mission. The Program Outcomes (POs) are centered around skills, competence, and knowledge that students are expected to acquire by the end of their program, while COs focus on the knowledge gained and the ability to apply it after completing individual courses.

To ensure the attainment of POs and COs, the institution follows the evaluation process outlined by the UGC and parent university guidelines. The syllabus displays the evaluation scheme, and the attainment levels are calculated through mapping the CO and PO matrix. Both direct and indirect methods are employed for measurement. The direct method involves assessing CO and PO attainment based on performance in Continuous Internal Assessment and Semester End Examination (SEE). Question papers for SEE cover all COs, with questions aligned to various Bloom's Taxonomy knowledge levels. Quality assurance is maintained through question paper audits.

Course teachers assess CO attainment through non-zero marks scored for each question by students in SEE. Course attainment levels ('0', 'A', 'B', 'C') are assigned based on performance ranges. PO attainment is then evaluated as an average of course attainments. The indirect method involves evaluating performance in activity-based tests, projects, employability, progression, and entrepreneurship. Projects are designed to address real-world challenges, encouraging group work and leadership skills.

The effective implementation of the OBE policy and a student-centric educational system has positively impacted students' skill sets, knowledge, competence, progression, and employability. The institution's commitment to these principles

reflects in its rigorous curriculum development, communication strategies, and comprehensive evaluation mechanisms.

Attainment of COs, PSOs and POs:

The learning outcomes relate to skills, knowledge & behavior and describe what students are expected to know, be able to do after the completion of each course/programme. For measuring the attainment of COs, PSOs and POs the institution has a mechanism as follows:

- The attainment of COs, PSOs and POs, shall be measured on the basis of performance in CIA, practical examinations (for practical oriented courses) and Semester End Examinations.
- The ratio of 40:60 for CIA: SEE is followed. 10% of the total marks of course are allotted for class/laboratory attendance.
- For all UG and PG programmes, formative evaluation includes two unit tests. One of these Unit tests is Activity based wherein learners prepare Surprise Test, Quiz, Poster Presentation, Power Point Presentation, Group Activity, Book Review, Model Making, Seminars, Field Visit, Survey, etc. The question paper pattern for Unit Test II is objective in nature. The nature of question papers for SEE is designed by the respective BoS and is subjective.
- Students performance in formative evaluation is counted for the measuring of attainment of COs.
- Learners performance in the summative evaluation is taken into account for measuring attainment of PSOs and POs.

Evaluation of COs, PSOs/POs Attainment:

COs, PSOs/POs attainment is evaluated through academic performance in the CIA and SEE. Attainment benchmark is set by BoE as follows.

- COs attainment level is minimum score of 40% marks in the specific course.
- PSOs/POs attainment level is based on the overall performance described as follows.
- Employability of students, progression of students, entrepreneurship is also considered for overall evaluation of attainment of PSOs/POs.
