The material will include hereafter as all forms of e-waste and/or e-scrap collected out of discarded electronics equipments of all kinds as per the list attached herewith,

including but not limited to IT Equipments like printers, printer cartridges, faxes, copiers, spares.

It should also include, but not limited to laptops, notebooks, desktops. servers, network personal equipment, monitors, cathode ray tubes, liquid crystal displays, telephones, data assistants, mobile phones, process control equipment server towers, server racks, scanners, batteries, electronic storage media, all accessories, components and peripherals for above mentioned equipment.

In consideration of the mutual promises set forth herein, the First Party covenants and agrees that it shall as written in the MOU. The Second Party covenants and agrees all the terms and conditions of this MOU. This MOU may not be modified in any manner unless in writing and signed by both parties. This document and any attachment here to constitute the entire MOU between the parties. This MOU shall be blinding upon the parties, their successors, heirs and assigns and shall been forced under the laws.

CONFIDENTIALITY:

Confidential information means any and all information in whatever form provided by the disclosing Party and relating to the Activities, provided such information is either (a) marked as confidential at the time of disclosure; or (b) if not in a form that can be readily marked (e.g., an oral, visual or electronic form), is identified by the disclosing Party as confidential at the time of disclosure, or (c) if, given the circumstances of the disclosure, the receiving Party reasonably ought to know that it should be treated as confidential. No disclosure under this MOU or Project Agreement shall be considered an offer to sell or a public disclosure.

TERM OF MOU:

This MoU shall commence on the date of this MoU above and shall remain in effect for a period of five (05) years. Either party may terminate this MoU by giving Thirty (30) days prior notice to the other Party. This MoU can be extended by mutual written agreement of both Parties. The termination of this MoU shall not affect the implementation of the projects established under it prior to such termination.

DISPUTE RESOLUTION:
