

DL. 22/02/2021


The meeting of Grievance Redressal Committee (students) was held on 22/02/2021 at 3:30 pm in Cultural Unit of College.



Agenda 2: - Last meeting minutes.


→ Dr. Anirudha Birajdar started the discussion on arrangement of a expert-talk for releasing stress due to covid19 situation.


