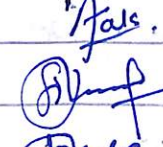
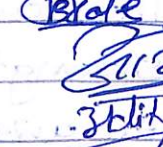
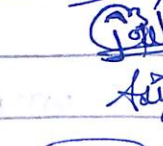
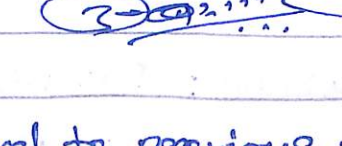
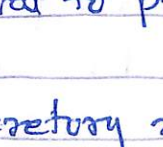
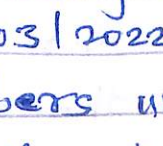
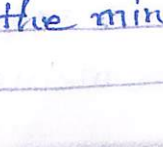
The meeting of anti-ragging committee was held on 22. Aug, 2022 at 11:00 am in Management hall. Following agenda points were discussed.

Agenda 1: To read and confirm the minutes of previous meeting held on 22nd August 2022.

Discussion: Dr. Anirudh Birajdar read out the minutes and action taken report of previous meeting held on 22nd August 2022.

Resolution: The committee unanimously confirmed the minutes of previous meeting held on 22nd August, 2022.

Agenda 2: Discussion and decision about the complaint received [complaint No. MH_0057].

Discussion: Dr. Anirudh Birajdar briefed the Anti-ragging Committee about complaint received from Mr. XYZ student through online portal of UGC [complaint No. MH_0057]. The committee interrogated Mr. XYZ student who had accused of ragging. The committee found the altercation began between the Mr. XYZ and a girl student ABC after the girl refused Mr. XYZ's friend request on social media platform, which led to a scuffle. Reacting to this, Mr. XYZ lodged a false complaint when a girl student ABC refused his friend request and apologized for the same. Following his written confession, the Anti-ragging Committee suggested authorities to inform the University Grants Commission (UGC) about the false complaint.

Resolution: The Anti-ragging committee unanimously suggested informing UGC about the false complaint and counseling the victim from Psychological Counselor so that he feels safe and knows that authorities are with him.

In the end, Dr. Anirudh Birajdar (Secretary of Anti-ragging Committee) expressed vote of thanks and meeting concluded.
